Collaboration with Fries tourism has been instrumental in positioning the Theatre as a hub for cultural enrichment and community engagement.

Cultural and Community Impact

The Theatre is a cherished venue for both young and old. Young people learn about Appalachian culture and heritage, traditional instruments, and the importance of dance in connection with music. Older individuals enjoy the fellowship and camaraderie of hearing familiar tunes.

The weekly jam sessions have attracted a significant number of visitors to Fries. Many people from out of town plan their vacations around the jam sessions, staying from Thursday to the following Thursday night to attend twice. Recent visitors have come from Holland, France, England, Canada, California, New Mexico, Colorado, New York, Florida, Ohio, and many other states.

Evolving into a Cultural Center

Gentrification, the process where local residents are priced out of their homes by newcomers who are attracted to a trendy area, has impacted Fries to some degree. This complex phenomenon elicits varying opinions but is often driven by uncontrollable forces. Effective management is crucial, as gentrification can erode local culture. The Historic Fries Theatre addresses this by preserving the community's heritage through weekly jam sessions, Friday night concerts, and displays celebrating Fries' history and culture.

Notably, the Theatre is evolving into more than just a music venue. We are shaping it into a museum and cultural center that tells the story of Fries, the mill, and their connection to Appalachian music and dance. Visitors and residents come not only to enjoy music and dance but also to immerse themselves in the town's rich history and heritage.

Recent Updates and Financial Information

We recently repaired the neon sign. The cost, expected to be around \$800, isn't reflected in the current financial statements as they are on a cash basis and the final bill has not yet been received. Donations for the repair totaling \$200 were received from Tina Privette, James Danford, Eddie Bond, and Bonnie Bond.

August Highlights

Throughout August, the Theatre achieved several milestones:

- 1. Hosted a well-received exhibition of photography by local visual artist Mark V. Sanderford. Sanderford was the winner of the inaugural Fries Musical Heritage award presented at the Fries Fiddlers' Convention. Numerous guests attended the exhibitions who would not have otherwise attended the jam sessions.
- 2. Collaborated with the Fries Musical Heritage Committee to restart the Fries Fiddlers' Convention. The convention was a resounding success. More with the tourism report
- 3. Hosted a couple of Facebook Live sessions from the jam.
- 4. Continued publicizing outdoor concerts, with bands booked for performances through October.
- 5. Bought a sandwich board-style sign to publicize music on Thursday nights at the jam and Friday nights at The Depot.
- 6. Successfully hosted the concerts in May, June, and July with the Whitetop Mountain Band, the New Ballards Branch Bogtrotters, and Trish Fore & the Wildcats.
- 7. Held highly successful jam sessions, drawing 90 to 110 visitors per session in August, providing entertainment and fellowship for locals and visitors alike.
- 8. Continued efforts to maintain the cleanliness of the Theatre and community center grounds.

August continued a marked increase in traffic in town that began in May.

Action taken:

- Collaborated with a group of community leaders and musicians to continue the Fries Fiddlers' Convention after Fries Fire and Rescue chose to discontinue it.
 - o Event was held August 16-17 at the Fries Ballpark

 - o Granted live interview to WPAO
 - o Produced another video about the concerts
 - o Printed posters and flyers and distributed them
- Continued efforts with a group of local concerned citizens and music lovers to revive the Fries Fiddlers Convention
 - o Event will be held August 16-17 at the Fries Ballpark
 - o Event conducted under the umbrella of Fries Tourism
 - o It will be a totally non-profit event with excess funds being held over for next year's convention and also going to a music scholarship for children and young people

- Represented the town in numerous festivals and public gatherings. Set up a tent at the Beerfest and engaged with many people about Fries.

Report Overview

This report provides an update on the recent activities and developments at The Historic Fries Theatre. It also presents financial statements for the year-to-date period ending June 30, 2024, and a listing of financial transactions for the non-profit corporation for the year to date.

Dedication to Community and Economic Growth

The Theatre board and management remain dedicated to maximizing the town's assets by diligently leveraging the Theatre to attract visitors to Fries and stimulate economic activity. Collaboration with Fries tourism has been instrumental in positioning the Theatre as a hub for cultural enrichment and community engagement.

repaired. She hoped they could now take the seniors on more trips. She reported that the group wants to go to Mt. Airy once a month to Aldi's for grocery shopping. She reported that they had recently lost one of their long—time members, Mrs. Wanda Dowling, and that she would be greatly missed. The Mayor thanked her for her report.

- 4. <u>Fries Fire & Rescue</u>: James Young reported that the Independence Day parade would be held on Thursday, July 4^{th at} 2 pm. Fireworks were planned for Saturday, July 6th at 9:30pm. The Fire Department and the Community Center also planned to host a Fun Day in the Town Park on July 6th from 6pm—9:30pm. He also reported that the next horseshow would be held on September 21st. Rain date was scheduled for September 28th. The Mayor thanked him for his report.
- 5. <u>Friends of Fries</u>: Mary Ann Cubbage reported that they were just trying to keep the plants alive through the current drought watch. The Mayor thanked her for her report.

Old Business:

1. Brian Edenfield: Carrico Street Campground Plans & Fenders Curve Update:

Mr. Edenfield reviewed his proposed plans within the town. He reported that the hotel and condo rentals had greatly improved and were doing great. He and a business partner had recently purchased the New Riverside Store and Deli and he asked that people come and see the changes they were making. He also stated that he had no plan to move the outfitters that was currently located in the store. Then he asked that council and the planning committee review the proposed plans that he had recently submitted as he would like to have approval as soon as possible. The Mayor thanked Mr. Edenfield for his report.

2. <u>Fries Community Center Letter</u>: The Mayor reviewed a recent letter that she had written to the Fries Community Center concerning the rental agreement signed in April.

New Business:

- 1. <u>SERCAP Grant for WWTP Influent Panel & Pump</u>: The Mayor reported that the town had applied for and had been awarded \$40,275 to replace the failing panel and pump at the wastewater treatment plant. She read the award letter aloud.
- 2. <u>Fire Department 2024 ATL Funds</u>: The Mayor presented James Young of Fries Fire and Rescue with a check for \$15,000 in ATL funds that the town had applied for and received on behalf of the FVFD.
- 3. <u>2023 Paving Bill:</u> The clerk presented a bill for \$33,462.95 that had been received for the paving work that had been completed in 2023 and asked for approval to pay the bill. After some discussion, Jo Ann Gunter moved to table the matter until legal representation could be secured and review the matter. Richard Hawks provided the second. The Mayor called for a vote. Bill Davis, Yvonne Burr, Johnny Dickson, Jo Ann Gunter and Richard Hawks voted Aye. Mary Ann Cubbage and James Young voted Nay. The matter was tabled.

- 4. <u>WWTP Grinder Control Panel:</u> The clerk presented an estimate for a new grinder control that had recently failed at the wastewater treatment plant for council review. No action was taken.
- 5. <u>Jeff Key: Fries Community Center/Theater Parking Sign:</u> Mr. Key stated that he had come to the meeting about the theater parking sign, but had seen that it had been corrected to say Thursday night. He also stated that he didn't think the sign was fair and that it should be removed.
- 6. <u>Angela Shupe: Fries Community Center/Theater Parking Sign:</u> Mrs. Shupe spoke briefly about her background and how the community center was an important place for her and her family. She stated that she was blindsided by the sign and felt that the sign was unnecessary. She asked that the sign be removed and that council look into making the bottom floor of the community center handicap accessible.
- 7. <u>Michelle Shupe: Fries Community Center/Theater</u>: Ms. Shupe spoke concerning the division of the theater from the community center. She felt that there was a good group of volunteers trying to give kids things to do at the community center and she hoped everyone would start working together.
- 8. <u>Valerie Archer: Fries Community Center:</u> Mrs. Archer spoke briefly about her background with the community center. She stated that she felt that the theater parking sign gave the impression that the youth sports programs were less important than the theater. She stated that she was sure that had not been the intention of the sign installation, but she felt that the sign was not inviting and should be removed. She suggested a possible solution of designating the entire parking lot handicapped parking only.
- 9. Rebecca Johnson: Fries Community Center: Ms. Johnson spoke briefly about her background and then commended the new board of the community center for cleaning up the center and the pool. She stated that she felt it wasn't fair to prioritize one part of the community over the other and that the sign should be taken down. She also suggested making the entire parking lot handicapped parking only.
- 10. Eddie Bond: Fries Theater: Mr. Bond spoke about the history of the Thursday Night Jam, explaining that it had been going on for 40 years, and since joining The Crooked Road Music Trail it now drew visitors worldwide. He explained how volunteers had spent time and money renovating the theater, making it a beautiful venue for young and old. He then addressed the parking issue. He stated that parking is limited around the center and since a large number of the people who attend the jam were elderly, it caused them issues. He asked for the cooperation of the community center with scheduling on Thursday nights, since it was only one night a week for a few hours.

The Mayor then asked for council opinion concerning the sign. Bill Davis asked if things were working before the sign. Eddie Bond responded no they were not. Jo Ann Gunter stated that we all needed to work together and that one night from 5—10pm shouldn't be too much to ask. Johnny Dickson did not like the wording on the sign. Richard Hawks thought the sign should be removed. James Young thought the sign should be removed. Mary Ann Cubbage discussed the option of making the lot handicapped parking only. Yvonne Burr stated that the sign would not help and that scheduling was the real issue.

She then read aloud a letter from the Community Center Treasurer that stated that they would not schedule events on Thursday night unless it was unavoidable.

11. <u>Johnny Moore: Fries Community Center</u>: Mr. Moore read aloud the Community Center's response to the Town letter of concern and spoke about many things he felt were issues. Mr. Moore went over his allotted time to speak and when reminded, he refused to yield the floor. Mr. Griffith, a Fries citizen, intervened and asked Mr. Moore to lower his voice and be respectful.

After some further discussion, the Mayor stated that we all wanted the town to thrive. All of us. The sign was installed in an effort to alleviate a problem. It may not have been the solution, but it was not intended to divide.

With further business to discuss, JoAnn Gunter moved to adjourn. Yvonne Burr seconded the motion. All present voted Aye and the meeting was adjourned.

In the Twin County area, the amount was approximately \$80 million. (Figures provided by Virginia Tourism Corporation in the report Direct Economic Impact and Spending Shares by Industries, 2022).

2. <u>Fries Historic Theatre:</u> Kevin Combs reported the following:

Fries Town Council Fries, Virginia June 4, 2024

This report will provide you with an update on the recent activities and developments at The Historic Fries Theatre, as well as present financial statements for the year-to-date period ended May 31, 2024, and a listing of financial transactions for the non-profit corporation for the year-to-date through the first few days of June.

As always, the Theatre board and management have remained dedicated to maximizing the town's asset by working diligently to leverage the Theatre as a means to attract visitors to Fries and stimulate economic activity. Collaboration with Fries tourism has been instrumental in this effort, as we continue to position the Theatre as a hub for cultural enrichment and community engagement.

The venue is a treasure for young and old alike. Young people learn of the Appalachian culture and heritage while learning to play traditional instruments and understanding the importance of dance and its connection with the music. Older folks enjoy the fellowship and camaraderie of hearing the tunes played again and again.

It is astounding how many people come into Fries to attend the weekly jam session. Many folks from out of town plan their vacations around the jam and arrange it so they can come in Thursday and stay through the following Thursday night – just so they can attend the jam twice.

An incident I recently witnessed indicates the impact the Theatre has on the town and its fans. I was talking to a man from Ohio who frequents the jam – driving here from Ohio just to participate in it, and I assume arranging for an overnight stay here. As we finished our conversation and he walked away, he repeated three times, "This is such a wonderful place!"

One of the notable transformations taking place at the Theatre is its evolution into more than just a music venue. We are actively shaping it into a museum and cultural center that tells the story of Fries. Visitors and residents alike come not only to enjoy music and dance, and to socialize but also to immerse themselves in the rich history and heritage of our town.

Throughout the month of May, the Theatre achieved the following milestones:

- 1. Continued adding Virginia is For Lovers merchandise for sale at the Theatre.
- 2. Continued collaboration with the Fries Musical Heritage Committee to restart the Fries Fiddlers' Convention.
- 3. Continued publicizing the outdoor concerts which began in May, with bands booked for performances through October.
- 4. Successfully hosted the first concert in May with the Whitetop Mountain Band.

- 5. Held five highly successful jam sessions, drawing visitors from across the country and even internationally, and providing entertainment and fellowship for locals and visitors alike, and drawing typically 70-80 visitors per jam.
- 6. Continued efforts to maintain the cleanliness of the Theatre and community center grounds.

In conclusion, The Historic Fries Theatre remains committed to its mission of preserving our town's heritage while serving as a catalyst for cultural enrichment and economic development. We appreciate the continued support of the Fries Town Council and look forward to further collaboration in the months ahead.

- 3. <u>Fries Community Center:</u> No report was given.
- 4. <u>Fries Fire & Rescue</u>: James Young reported that the Independence Day parade would be held on Thursday, July 4th. Fireworks would be held on Saturday, July 6th at 9:30pm. The Fire Department also planned to host a Fun Day in the Town Park on July 6th from 6pm—9:30pm. The Mayor thanked him for his report.
- 5. <u>Friends of Fries</u>: Mary Ann Cubbage reported that the Friends of Fries had spruced up the caboose flower beds and were raising funds to install a new picnic table in the caboose area. The Mayor thanked Mary Ann, Richard and Rachel Hawks, and the Friends of Fries for providing free coffee for the Saturday Markets for last year and the start-up of this season.

Old Business:

1. <u>FY2024/2025 Budget</u>: The Mayor reviewed the published budget and proposed changes. After some discussion, Mary Ann Cubbage moved to adopt the budget as presented and advertised. Yvonne Burr provided the second. There was no further discussion. All present voted Aye and the FY24/25 budget was adopted.

New Business:

1. Brian Edenfield: Carrico Street Campground Plans & Fenders Curve Update:

Mr. Edenfield stated that he was there to update the council on his holdings within the town. He reported that the hotel and condo rentals had greatly improved and were doing great. He and his former partner, Mr. Reeves had amicably parted ways. He and another business partner had recently purchased the New Riverside Store

and Deli and he asked that people come and see the changes they were making there. He then handed out a packet of updated plans for his three upcoming projects. They were:

- <u>Carrico Street River lots</u>: Mr. Edenfield stated that he had submitted his plans to Grayson County and was expecting approval shortly. He had changed the scope of the project since his last zoning approval from the town from building 4 tiny homes and selling the 4 lots individually to a 16-site RV short-term rental campground. Richard Farmer stated that he thought it was a great idea, but thought the town should implement an ordinance to regulate in the long term.
- <u>Fender's Curve River lots</u>: Mr. Edenfield reported that a traffic study had been done in the area and that he was awaiting approval from VDOT concerning the use of the entrance. He planned to sell the lots off individually "as is" without making any changes to the property.
- <u>Housing Subdivision</u>: Mr. Edenfield reported that he had included an updated plan for the subdivision, but planned to do a few fewer homes on the property to allow for green space. He still asked that the town consider applying for grant funding to supply the water and sewer line infrastructure to the subdivision.

The Mayor thanked Mr. Edenfield for his plans and updates and pledged to forward the newly submitted information to the Planning Committee for review.

2. <u>Emerald Young: Problem with Emergency Services:</u>

Ms. Young reported that she was a resident of Turkey Knob and had recently had an incident with Twin County 911 that she wished to draw attention to. She reported that there had been a large fire on 57 acres of property near her home. She did not know of any controlled burns in the area, so she called 911 to find out if it was a wildfire or a controlled burn and get a status update. She spoke with Dispatcher Michelle Privett and reported it took 5 minutes to get Fries Fire Department dispatched. She felt that the 911 dispatcher withheld response due to her race. She asked to speak to Privett's supervisor, Whitney Smith, who ignored her requests for a review of the recording of the call and a copy of the call to be provided to her. She finally received a copy of the 911 call from Ronald Newman, who reviewed the call and found no evidence of racism, but he did not address what she felt was mismanagement of the call. She asked the council for their advice on how to proceed. The Mayor responded that the matter was out of the town's jurisdiction. James Young suggested that she continue to pursue the matter with Twin County 911 as the town had no jurisdiction over the matter. Ms. Young responded that she felt that she had been discriminated against due to her race and she wanted to publicize the matter to make it known that there was a problem with the 911 system. She thanked the council for hearing her complaint. The Mayor thanked Ms. Young for attending.

Announcements:

- 1. Golf Cart Permits are due. Inspection forms are available at Town Hall.
- 2. Personal Property Taxes are due tomorrow, June 5th. If you didn't receive your statement, please contact town hall.
- 3. Don't forget to vote in the Primary Election, Tuesday, June 18th.
- 4. New Orleans Jesuit High School Students will be in town July 14th through July 25th. Anyone needing work done or interested in helping with meals, contact Town Hall.

Johnny Dickson commented that the new part-time worker was doing a great job and that he should be moved to full-time as soon as possible. The Mayor explained that once he finished the required probationary period as prescribed by the personnel policy he could be moved to full-time.

Nancy Griffith commented that the sidewalks were looking great, but she had noticed cars pulling up on the sidewalk and parking. She was concerned the cars would cause the sidewalks to break up worse than they already are. The Mayor replied that she would look into the matter.

The Clerk reported that the wastewater treatment plant mower was officially beyond repair. She asked council's opinion on replacement pricing and for suggestions. Johnny Dickson suggested checking with the Cochran station on 89 for a replacement mower. James Young suggested that we only go with a commercial-grade mower. No price range was suggested, but the Clerk and Mayor agreed to bring three quotes before council to review.

The Mayor reported she had recently had a conversation with VDOT again and had asked about the paving that had been promised last summer. VDOT replied that Fries was still on the list to get paved this year.

Discussed requesting that VDOT re-visit installing a crosswalk to the upper parking lot due to a number of elderly and children that cross the road in that location. Also discussed adding signage to address parking issues in that lot for other issues. Charlie Lawrence suggested that council check into lowering the speed limit through town due to upcoming legislative changes that would give localities more input in doing so.

With no further business to discuss, James Young moved to adjourn. Johnny Dickson provided the second and the meeting was adjourned.

- 3. Fries Community Center: Johnny Moore reported the following:
 - *The center had paid for their lifeguard certification classes and had hired lifeguards for the pool season.
 - *The board had begun pursuing grants and funding for the center.
 - *The board had met with an auditor, April MacInnis, who then reviewed the books and gave them recommendations. All was in order.
 - *Spring sports were in full swing. Baseball and softball were underway.
 - *Their recent paint night had been successful with 40 participants.
 - *The Fries throws and Fries baseball hats were still available for purchase. They planned to have t-shirts available soon.
 - *The center was holding a fundraising raffle. The first prize was a Stanley Cup.
 - *The pool would be opening on May 24th.
 - *May 11th was a planned work day to prepare the pool for opening.

- *A roof leak was found in the gym over the bleachers.
- *They planned to replace the cover over the footwash before opening the pool.
- *After removing the old carpeting on the pool porch, they felt it to be a slip hazard. Johnny asked for council permission to paint the porch with sanded paint to avoid any slipping. Johnny Dickson moved to approve the request. Jo Ann Gunter provided the second. The Mayor asked if they had researched the paint for that purpose. Johnny Moore reported that he had found that they could not afford the epoxy paint that would be best for the surface. They were going to try the gray paint porch paint they had on hand and put sand in it to help stop slipping. Bill Davis suggested looking at outdoor carpet. Johnny Moore reported that they had some on hand, but not enough to cover the entire porch. They planned to put the carpet in the areas where the tile was uneven and use the paint everywhere else. After the meeting, Mr. Reeves submitted bids from Virginia Carolina Heating & Cooling and Carolina Vintage Air for mini-split systems as well as conventional heat pumps. The total for the units, labor, electrical upgrades and the metal & concrete work came to

a total of \$230,000. Mr. Chase stated that with numbers in hand he could now start to look for funding. He reported that Pete Huber and students were trying to help find funding also. Mr. Chase also had plans to meet with Tim Kaine on May 13th at the Galax Library and spoke with Josh Hess of Morgan Griffith's office to ask for funding suggestions. The Mayor thanked Mr. Chase for his efforts.

2. <u>Farmers Market Schedule:</u> The Clerk passed around the work calendar for the council to pick the days they planned to work the market. The Mayor asked that council members attend the vendor meeting and the first market day, May 25th to review market rules and set up procedures.

New Business:

- 1. <u>David Greenbaum: Bike Repair</u>: Mr. Greenbaum introduced himself to the council. A resident of Fries since 2021, he reported having a long history with bicycles. His work history included working for a bicycle company as well as many bike repair shops. While he was not interested in bicycle sales, he was interested in bike repair. He asked permission from the council to set up at the Market on Saturdays and provide free bike repair. He had contacted several local insurance agents to find liability insurance but hadn't yet found what was needed to proceed. Johnny Moore stated that he possibly had a contact to help. Council had no objections to Mr. Greenbaum providing free bike repair as long as he took care of the liability issue.
- 2. Resolution: Attorney Approval: The Mayor read the following resolution aloud:

A RESOLUTION APPOINTING SPECIAL COUNSEL TO CERTIFY CERTAIN CONTRACT DOCUMENTS.

WHEREAS, the Town of Fries (the "Town") has received a grant from the United States Department of Agriculture Rural Utilities Service ("RUS") to make certain emergency repairs to its water plant and distribution facilities (the "Project"); and

WHEREAS, RUS requires the Town to have certain contract provisions reviewed and approved by legal counsel authorized and acting to do the same.

NOW THEREFORE, the Council of the Town of Fries hereby resolves that it appoints Mr. Michael Lockaby, of the law firm of Spilman, Thomas & Battle, as its duly authorized and acting legal representative for the purposes of investigating and executing the Certificate of Owner's Attorney required by the RUS.

And this Resolution is in effect upon adoption.

Fries Town Council Joint Public Hearing with Fries Zoning Planning Board April 2, 2024 Minutes

<u>Call to Order</u>: The Mayor called the meeting to order.

The Mayor announced that the purpose of the meeting was to receive public comment on a variance request submitted for the property located at 305 Hampton Street that was under review by the Fries Zoning Planning Board. She apologized for Brenda Vaughan, Junior Anderson, and Bobby Jones who were unable to attend, and explained that Yvonne Burr was the council representative on the planning board and was in attendance to discuss the planning board's findings. She then opened the floor for public comment.

Diana Goodwin, owner/realtor of the property at 305 Hampton Street explained that the property was made up of several lots and she wished to separate the back lot and sell it as a buildable lot. She said that she thought a tiny home would fit nicely into the neighborhood. She stated that the property could meet the setback requirements and the only problem that she saw was that there was not enough road frontage to meet the current requirements.

Scotty Alley, a resident of Blair Road could not attend but sent an email stating that he felt that the lot was too small and should not be made a buildable lot.

Richard Farmer, a resident of Hampton Street spoke against the change stating that with the possibility of a housing development going in right across the fence that it would simply be too much development, too close together.

Tracy Burcham, a resident of Hampton Street stated that he didn't believe you should stick a house on a piece of property just because it would fit. He felt that if a home were built there, it would be too close to the adjoining properties.

Vickie Kirby, a resident of Hampton Street stated that while she wanted to see the town grow, she felt the lot would be too crowded. Because of Blair Road being very narrow, she felt that it would be difficult to get construction equipment onto the property without crossing onto the neighboring properties. She also felt that there would be drainage issues created by building on the lot in question that could be a problem for years in the future as there were already drainage issues there.

Richard Farmer reported that a large drainage line emptied onto the lot in question and made it swampy after large rainfalls.

Diana Goodwin said that if there were a drainage problem that it would have to be addressed during construction. She also stated that she understood the "not in my backyard" mentality, but she felt that if a tiny home was respectfully installed that it would be a benefit to the town.

Tracy Burcham stated that Ms. Goodwin had made the investment in the property at 305 Hampton with the knowledge that it was one property and he felt that it should remain one property.

The Mayor asked if there were any further comments and there were none. Yvonne Burr moved to adjourn the public hearing. Mary Ann Cubbage provided the second. All present voted Aye and the hearing was adjourned.

 - It will be a totally non-profit event with excess funds being held over for next year's convention and also going to a music scholarship for children and young people
- March 5-6 attended an online orientation with the Virginia Tourism Corporation.
- Continued scheduling events on website calendar for the year including events sponsored by Fries Fire and Rescue, the New River Trail State Park and others.
- Applied for a \$7,500 marketing grant with Virginia Tourism.
- Obtained sponsorship for an outdoor concert from The Crooked Road.
- Obtained sponsorship for a Friday night concert and dance at the theatre.
- Met with various Virginia tourism personnel in their areas of expertise such as Virginia is for Lovers, Virginia tourism grant application process, and co-op advertising opportunities.
- Followed up on an initiative whereby I contacted the vrbo owners and restaurants in town to feature them on the town's social media. I have met with the owners who have gotten back to me and featured some of them on social media. Still working on the process.
- Attended a grant writing workshop.
- Prepared rack cards and am in the process of refining them.
- Prepared a full-page ad to go in the Spring visitors guide of The Gazette.
- Worked with The New River Trail State Park rangers in bringing some programs by the park service into Fries.
- Worked with The New River Trail Race in getting volunteers and facilitating the race (April 13). (Note to town council: This race brings hundreds of people into town. The event organizer needs volunteers for the race. Please consider volunteering. You can go to the race website (newrivertrail50k.com) and click on the menu item "Get involved" for more information.)
- Attended a week-long video editing class with the intention of bringing more video to my arsenal of social media tools. Video is fast-becoming the medium of choice in social media advertising.

In case you doubt the impact tourism can make on Fries, consider these facts. Tourists spent approximately \$1 billion in the region of the state roughly from Patrick County to Washington County (Southwestern Virginia – Blue Ridge Highlands region) in 2022. Report to Fries Town Council By The Historic Fries Theatre April 2, 2024

> The Theatre board and management have continued to work hard to maximize the town's asset. Theatre board and Fries tourism cooperate to leverage the theatre to bring people into Fries to visit and spend money.

Theatre management is gradually transforming the theatre into more than a music venue. It is crafting it as a museum and cultural center for Fries. Visitors and residents come to hear or play the music, dance, and socialize. But on the walls of the theatre, they are told the story of Fries. I recently hung an original artwork of mine documenting work in the mill. It is currently hanging in the foyer.

During the month of March, the Theatre:

- Hosted a musical performance and live auction for the community center (including running the sound board for the event).
- Updated theatre listing on google.
- Began adding Virginia is For Lovers merchandise for sale at the theatre
- Continued working with the Fries Musical Heritage committee to restart the Fries Fiddlers' Convention (see tourism report)
- Finalized the dates and bands for 5 outdoor concerts at The Depot in association with Fries Tourism. Concert dates are set and bands are booked:
 - o May 24 The Whitetop Mountain Band
 - June 14 The New Ballards Branch Bogtrotters
 - July 12 Trish Fore and The Wildcats
 - September 20 The Crooked Road Ramblers
 - October 4 Gap Civil (sponsored by The Crooked Road: Virginia's Musical Heritage Trial)
- Scheduled a dance for April 12 with Leftover Biscuits. The band is already paid for by a generous donation from Charlie Lawrence.
- Saw the release of a country music video filmed at the theatre by regional artist Jamie Collins.
- Hosted a shoot for a video by regional artist Jim Lloyd.
- Hosted four highly successful jam sessions during the month of February. Visitors like the warm, family-friendly atmosphere and are always commenting on how much fun it is.
 - Jam sessions draw visitors into Fries from all over the country and even the world.
 - Serve 50-100 people a week, providing fellowship and entertainment for locals and visitors alike
 - Jam sessions bring people to Fries where they spend their money on the steakhouse and the café.

- Cleaned the theatre weekly, and picked up the theatre and community center grounds weekly (including numerous cigarette butts).
- Incrementally worked to add museum and cultural exhibits to the Theatre.

We have had a meeting of a few of our members and wanted to report to you some of our goals for 2024.

- Also, one of our members (Ed) is continuing to pick up litter on main road into Fries. One member (Johnny) mows grass along Riverview.
- 2. **Roundup spraying of main street sidewalks**: We would like to see the Main Street sidewalks kept free of weeds. We may be able to help with this
- 3. <u>New Raised Bed gardens behind Farmers market</u>. We can help disseminate information on growing vegetables successfully. Perhaps, we could meet with the senior citizens if they are to be the gardeners, and speak with them. In the future, we might be able to plant a pollinator garden in front of the raised beds.
- 4. **Farmers Market**: We would like to recommend that the farmer's market allow Yard Sales to take place, along with produce, food, and art. We think this will draw a number of devoted yard sale enthusiasts to the market and help with other sales. We strongly advise **not allowing clothing** to be sold, just household goods, tools, jewelry, boats, bikes, etc.
- 5. **Bus that is parked at Farmers market**: We think the bus could be parked someplace else, because it blocks the view of the market happenings and takes up valuable parking space for the market.
- 6. <u>List of churches</u>: a list of local churches will be sent separately and we recommend that this be used to send out letters to request their support of the Farmer's Market activities.
- 7. **Acoustics during your meetings**: It was noted that the acoustics are very bad for town meetings and perhaps a microphone could be used.

The parcel had been purchased and conveyed as a portion of the home and lot of 305 Hampton Street. Committee member Yvonne Burr reported that the parcel did not meet the current zoning requirements for road frontage or lot area to be a separate, buildable lot and therefore, the committee could not recommend approval of the request. Mary Ann Cubbage moved to continue the discussion of the matter further. Johnny Dickson provided the second. All present voted Ave and the motion carried. 1. <u>Tourism Report</u>: Kevin Combs reported that the following:

Report to Fries Town Council By Tourism Director March 5, 2024

February was another productive month for the Fries Tourism Department.

Action taken:

- Formed a group of local concerned citizens and music lovers to revive the Fries Fiddlers Convention
 - Event will be held August 16-17 at the Fries Ballpark
 - Event conducted under the umbrella of Fries Tourism
 - It will be a totally non-profit event with excess funds being held over for next year's convention and also going to a music scholarship for children and young people
- Continued scheduling events on website calendar for the year including events sponsored by Fries Fire and Rescue and the Fries Community Center.
- Met with Tracy Cornett of Grayson County tourism and familiarized myself with the grant process with Virginia Tourism.
- Initiated grant application and am putting the pieces together.
- Again met with Melissa Peddy of the 50k/25k race. Discussed possibility of a 5k race, but decided to put it off until next year
- Continued working with Emory & Henry on the Watershed project a profile of Fries.
- Finalized plans for the five outdoor concerts this summer and early fall.
- Began an initiative whereby I contacted the vrbo owners and restaurants in town to feature them on the town's social media.

The grant application to the Virginia Tourism Corporation is centered around the theme: Fries — where music rises with the mountains. With all Fries has to offer, it's hard to decide on one aspect to emphasize, but with the revival of the Fiddlers' Convention, it seemed that music was the easy choice. So, the grant application will center around traditional music and with so many events going on this year with music, it will be easy to market the town using that theme. Those events include — concert/dance at the Theatre, five concerts at The Depot, the Fries Fiddlers' Convention, and of course, the Thursday night jam at the Theatre (aka The Jam

at the Dam). In addition, additional attention will be called to Fries when Legends of Grayson honors Jessie Lovell and Evelyn Farmer in April.

I would like to encourage all members of town government to support and attend town events. I and many others in the community work hard to make the town attractive – to current residents, to visitors, and to possible future residents. Your support is greatly appreciated. You might not particularly enjoy say old-time music, or car shows, or wildflowers, but getting to these events shows your interest in the town, its residents, and its visitors. Residents and visitors are the future of the town, and it would be beneficial to the town to see your support, and for you to see what the town is doing to encourage visitation.

2. <u>Fries Historic Theatre:</u> Kevin Combs reported the following:

Report to Fries Town Council By The Historic Fries Theatre March 5, 2024

The Theatre board and management have continued to work hard to maximize the town's asset. Theatre board and Fries tourism cooperate to leverage the theatre to bring people into Fries to visit and spend money.

Theatre management is gradually transforming the theatre into more than a music venue. It is crafting it as a museum and cultural center for Fries. Visitors and residents come to hear or play the music, dance, and socialize. But on the walls of the theatre, they are told the story of Fries. We have hung some of my work of the area. Ken Landreth recently donated an advertising calendar from 1925 from John Rector's store. It is currently hanging in the foyer.

During the month of February, the Theatre:

- Worked with a committee to restart the Fries Fiddlers' Convention (see tourism report)
- Finalized the dates and bands for 5 outdoor concerts at The Depot in association with Fries Tourism. Concert dates are set and bands are booked:
 - May 24 The Whitetop Mountain Band
 - June 14 The New Ballards Branch Bogtrotters
 - July 12 Trish Fore and The Wildcats
 - o September 20 The Crooked Road Ramblers
 - October 4 Gap Civil
- Scheduled a dance for April 12 with Leftover Biscuits. The band is already paid for by a generous donation from Charlie Lawrence.
- Hosted a country music video photo session, bringing exposure to the theatre and business to the Fries Dam Steakhouse.

- Held a Valentine's Dance that was very successful. Marketed the dance heavily bringing much attention to Fries and the Theatre.
- Hosted five highly successful jam sessions during the month of February.
 - Jam sessions draw visitors into Fries from all over the country and even the world (see map).
 - Serve 50-100 people a week, providing fellowship and entertainment for locals and visitors alike
 - Jam sessions bring people to Fries where they spend their money on the steakhouse and the café.
- Prepared a new listing for The Crooked Road's website describing the theatre and jam session and replacing an old and very out-of-date listing.
- Cleaned the theatre weekly, and picked up the theatre and community center grounds weekly (including numerous cigarette butts).
- Incrementally worked to add museum and cultural exhibits to the Theatre.

Also submitted for council review were financial statements for the year-to-date period ending February 29, 2024, and a listing of all financial transactions for the non-profit corporation for the year.

- 3. Fries Community Center: Johnny Moore reported that the free community meal that the center provided on February 24th had been successful. They served 30 people onsite and delivered several to-go meals locally. They planned to continue the free meal every month. He reported that basketball season was almost over and the last game would be held on Saturday, March 9th. Baseball signups were underway and registration forms were available in the Fries Library. The center hosted 10 students from Holy Cross starting March 1st. The students completed several projects such as painting the dining room and cleaning up at the ballpark. Town Council was scheduled to provide a meal for the students on Wednesday, March 6th. He announced their upcoming events were: a live auction, pinto bean supper and music by Elizabeth & Phillip Vaughan would be held on Saturday, March 9th beginning at 5 pm and an Easter Egg Hunt on Saturday, March 23rd in the ballpark from 12—4 pm. He reported that they had cleaned and started working the bowling alley and had recently had a party there. They had pursued the donation of bowling alley lanes and equipment from the old bowling alley in Galax that had closed and planned to use the materials donated for repairs. He also reported that the community center was partnering with Grayson County to find a grant to abate the asbestos from the pipes in the bowling alley. In conclusion, he reported that the center was looking forward to getting the pool open for the summer months. The Mayor thanked him for the report and the efforts of the new board.
- 4. Fries Fire & Rescue: No report submitted.

5. Friends of Fries: No report submitted.

Old Business:

There was no old business discussed.

New Business:

- 1. Tri-Area Community Health, Inc.: Chief Operations Officer, Pat Moles: Ms. Moles introduced herself and gave a brief update on the progress at the Fries facility. She reported that the new x-ray machine had been purchased and installed. However, the window that the x-ray technician would stand behind while operating the machine was damaged during shipping. They were waiting for the replacement window to arrive and be installed so that the machine could be useable. She also reported that the pharmacy construction had been completed and the facility had been inspected. To be able to operate they still needed their application to sell drugs that had been submitted to the DEA to be approved and were also working to secure their contracts with various insurance companies. They hoped to have the pharmacy open soon. She encouraged locals to consider becoming patients at the Fries facility in the near future. The Mayor thanked Ms. Moles for her update.
- Grayson County Agricultural Fair: Rebecca Roberts: Ms. Roberts gave a brief history of the fair, which has been held annually for three years. This year the fair was scheduled for August 9th, 10th, and 11th. They planned to extend the hours for the fair and hoped to pull in more vendors. She reported that vendors such as Duck Donuts and Sassy Good Eats had committed to the fair, but she was still looking for funnel cake and freshly squeezed lemonade vendors. She reported that Wayne Henderson would be holding a concert on one night of the fair, and she hoped to get another local group to play. She also asked that local artists and crafters get involved and enter the art division. She felt that Fries was under-represented in past fairs and hoped Fries citizens would be more involved this year. She asked anyone who was interested in participating or had ideas to contact her at 276-768-8162. She also reported that the artisans and crafters that participate in the Ag and Art Festival-Farm and Artisan Tour in September join the artisans meeting in August to organize. The date and time were to be announced at a later date. She suggested that the local Fries artists and crafters set up at the Fries Town Market and be included in the tour. The Mayor thanked Ms. Roberts for her report and for her efforts to include Fries.
- 3. <u>Development Project: Chad Reeves</u>: Mr. Reeves presented a new site plan for the proposed development of the former Delp property at 917 E. Main Street. The plan included 58 new parcels with houses, all parcels with a minimum area of 11,000 square feet and a maximum of 12,750 square feet. The plan also provided the street layout, as well as the water and sewer connection sites. Mr. Reeves also presented the proposed house design plans for the homes. After some discussion and council review, the Mayor suggested the next step would be to schedule a meeting with Brian Reed of the Mount Rogers Planning District Commission. She thanked Mr.

Reeves for the presentation and reported that she would be in touch with a meeting date and time in the near future.

4. Boiler Issue: Saul Chase: Mr. Chase announced his new initiative entitled "Stop the Coal Dust." The purpose of his initiative is the find an alternative heating solution for the Fries Community Center building and stop the use of the antiquated coal boiler. He presented an action plan that stated:

Actions requested from the Town of Fries: Authorize Town of Fries Employees to conduct a tour of the Fries Community Center for a certified HVAC-R technician so information can be collected to develop a comprehensive proposal for an HVAC system for the center that will eliminate the need for use of the "National Boiler." Authorize Mr. Chase to work with Debra Jones, grant writer for Grayson County, to prepare proposals to grant agencies, preferably for grants that do not require a monetary match from the Town of Fries, for the consideration of the Fries Town Council and Fries Community Center Board of Directors. Authorize Mr. Chase and Ms. Jones to develop activities that will demonstrate community support for "Stop the Coal Dust." Mr. Chase will seek endorsement from the Fries Town Council and the Fries Community Center Board of Directors before implementing any activities. Authorize Mr. Chase to attend Fries Community Center Board of Directors monthly meetings to seek their members' input and keep them informed regarding "Stop the Coal Dust" activities. Serve as a repository for financial contributions made to "Stop the Coal Dust." Authorize town staff to work with Ms. Jones and Mr. Chase in preparation of the grant proposals. Authorize town employees to assist in the grant application process, and upon acceptance of a grant, serve as fiscal agents to receive and dispense funds and implement the requirements as stated in the grant authorization.

Mr. Chase proposed securing funding to install mini splits all over the building for zone heating and cooling instead of a central unit that would provide heating and cooling to the whole building as it would be most cost-effective. He reported that the library, theater and dining room all had zone heating and cooling and it seemed to be working. After some discussion, Mr. Chad Reeves offered to assist with the project as he was a licensed HVAC contractor. Johnny Moore, Vice Chairman of the Fries Community Center, expressed his concern about the cost of operation of the individual mini splits. The center is responsible for the majority of the electric bills in the building and he was concerned that the operation of all those units would cause a financial hardship for the center. The Mayor replied that there seemed to be a lot of details that would need to be hashed out, but that Mr. Chase seemed to be on the right track to resolving the issue. She suggested that a meeting be scheduled with Mr. Chase, Mr. Reeves and Mr. Moore at Town Hall to discuss the issue in further detail. No formal action was taken by council. The Mayor thanked Mr. Chase for his report and his efforts.

5. Closed Session: VA Code Section 2.2-3711.A:

Pursuant to the Virginia Freedom of Information Act, Council by affirmative vote went into closed session as provided by Section 2.2-3711. A. (Moved by Yvonne Burr, Mary Ann Cubbage provided the second).

James Young moved to exit the closed session. Johnny Dickson provided the second. All present voted Aye and the motion carried.

As required in Section 2.2-3712.D of the 1950 Code of Virginia, as amended, Council certified that to the best of each member's knowledge, (i) only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and (ii) only such public business matters as were identified in the motion by which the closed meeting was convened were heard, discussed or considered in the closed meeting by Town Council.

After returning from the executive session, the clerk presented the renewal contract for the caboose property between the town and Jessica Newton of the Frosty Monkey. After some discussion, Johnny Dickson moved to approve the contract as written and continue to lease the property to Jessica Newton of the Frosty Monkey. Yvonne Burr provided the second to the motion. All present voted Aye and the motion carried.

The clerk reported that both pumps at the Blairtown pump station had gone out and then presented a quote for a new 3hp replacement pump for \$4,400 plus shipping charges and installation. After some discussion concerning the options of rebuilding or buying new, Junior Young moved to purchase two new replacement pumps for the pump station at an approximate cost of \$8,800 plus shipping, and any unforeseen costs due to installation. Yvonne Burr provided the second to the motion. All present vote Aye and the motion carried.

With no further business to discuss, Johnny Dickson moved to adjourn. Junior Young provided the second and the meeting was adjourned.

<u>Call to Order</u>: The Mayor called the meeting to order.

Invocation: Jo Ann Gunter gave the invocation.

<u>Minutes & Bills:</u> Johnny Dickson moved to dispense with the reading of the minutes and to approve the minutes and bills as presented. Richard Hawks provided the second to the motion. All present voted aye and the minutes and bills were approved.

Police Report: Deputy Johnson provided the police report for the month of December, which included: 1 fourth search and 1 warrant. Routine activities that included: 265 closed business checks, 15 service calls, 66 church checks, 89 directive patrols, 43 open business checks, 11 forestry checks and 12 warrant service attempts for a total of 177 hours. The officer then reported that the county had applied for and would be receiving a grant to install three new license plate reader cameras in the county. The cameras would be solar powered and would hold the license plate data for 30 days. In the case of missing children, the camera would automatically notify police if a wanted plate was photographed. The camera would not detect speed. The Sheriff's Department planned to monitor the cameras and data they provide. He asked that one of the new cameras be installed on town property and be dedicated to the town. He proposed installing the camera in the curves below the Fries Community Center. After some discussion, James Young moved to allow the Grayson County Sheriff's Department to install a license plate reader camera on town property. Yvonne Burr provided the second. All present voted Aye and the motion was approved.

Organization Updates:

1. <u>Historic Fries Theatre</u>: Kevin Combs reported that the Historic Fries Theatre (The Corporation) had completed all organizational requirements to operate as a charitable organization. It had complied with IRS, Commonwealth of Virginia and Town of Fries requirements.

The Board of Directors were listed as Yvonne Burr (incorporator), Kevin Combs, Eddie Bond (accomplished old-time musician and NEA award recipient) and Dr. Charlie White (President emeritus of Wytheville Community College).

He reported that the Theatre's main events had been the Thursday night jam sessions and a New Year's Eve dance and concert. The Director of The Crooked Road, Tyler Hughes, visited the December 14th jam. All events had been well attended.

He also submitted a statement of financial position for the month of December for the theatre for council review.

He reported that the board planned to host more events in the new year including: Friday night old time concert and dances occasionally, displaying art in the theatre with work from

local artists and hosting exhibitions of local visual art. Management was open to suggestions for other cultural events.

He also reported that upcoming issues for the theatre included: heating the facility in an economical manner, maintaining cash flow through the lean winter months and locating the meter for the electrical service to change the service into the name of the theatre. The Mayor thanked him for his report.

- 2. Tourism: Kevin Combs thanked council for appointing him as Tourism Director for the Town of Fries. He had been a lifelong supporter of Fries, and looked forward to serving the town. He reported that he had redesigned the town's website two years ago and continued to update it. He also maintained the town Facebook page and Instagram account. He reported that since being appointed he had: met with Nan Chase and received marketing materials she had in her possession, met with Tracy Cornett with Grayson Tourism and established a relationship, made contact with Melissa Peddy of New River Trail Races and Erin Pitts, Chief Ranger Visitor Experience with the New River Trail and scheduled meetings with them, updated the 2024 events on the website calendar (events include the New River Trail 50k/25k, Thunder by the River Cruise-Ins, Spring and Fall Wildflower Walks and Thursday Night Jams.) and worked with the new theatre board to make the theatre a cultural arts center. The Mayor thanked him for his efforts and report.
- 3. <u>Fries Community Center:</u> James Young reported some plumbing issues in the building, such as a commode running, a urinal that needed repair and a floor drain that was clogged in the women's locker room. He also asked if the boiler room had been locked due to the asbestos surrounding the boiler. The Mayor replied that it was possibly a health hazard and the locks were changed to reduce traffic in the room.
- 4. <u>Fries Fire & Rescue</u>: James Young reported that the department had ran 100 fire calls and 500 EMS calls in 2023. The paid EMS staff at the firehouse had begun January 1^{st.} The paid service provided EMS staff in the building on Monday through Thursday from the hours of 7am—7pm. They hoped to have Fridays covered in the near future. Volunteer EMS still staffed the building on nights and weekends. The Mayor thanked him for his report.
- 5. <u>Friends of Fries</u>: Mary Ann Cubbage reported that the group had not had a formal meeting recently, but wanted to work on a pollinator garden at the depot in the spring and possibly host a home and garden tour in the near future as a fundraiser for the group.

Old Business:

There was no old business discussed.

New Business:

- 1. <u>Announcements</u>: The Mayor then read the announcements which were:

Pursuant to the Virginia Freedom of Information Act, Council by affirmative vote went into closed session as provided by Section 2.2-3711. A. (Moved by Yvonne Burr, Mary Ann Cubbage provided the second).

James Young moved to exit the closed session. Yvonne Burr provided the second. All present voted Aye and the motion carried.

As required in Section 2.2-3712.D of the 1950 Code of Virginia, as amended, Council certified that to the best of each member's knowledge, (i) only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and (ii) only such public business matters as were identified in the motion by which the closed meeting was convened were heard, discussed or considered in the closed meeting by Town Council.
